In 2015 the YMCA of Metuchen, Edison, Woodbridge & South Amboy provided \$520,844.16 in financial assistance. Of that, \$144,437.01 was used towards childcare. Whether a single-parent or parents trying to make ends meet, our Y makes

YOUR IRA/RETIREMENT PLAN

You can name the Y as the beneficiary of a portion of or your entire IRA or retirement plan simply by changing your beneficiary form designation, which is a tax-effective way to make your planned gift.

AN INSURANCE POLICY

This type of gift allows you to list the Y as a beneficiary of a life insurance policy and is a very simple way to complete a planned gift.

YOUR WILL

A designation in your will to benefit the Y, of either a fixed amount or a percentage, is the simplest type of gift and the easiest to implement.

A CHARITABLE GIFT ANNUITY/TRUST

A charitable gift annuity is an easy way to make a gift to benefit the Y while providing you with a lifetime stream of income. You will receive an immediate tax savings combined with the assurance of lifetime income, all while sharing remainder values with the Y. These can be structured various ways to address estate planning concerns, such as, tax efficiency, philanthropic intent and family inheritances.

AN OUTRIGHT GIFT

These gifts can include cash, land, stock, real estate and personal property. By donating appreciated stock or securities, you may get a double tax savings – capital gains savings AND income tax savings.

STAFF GIVING: HOURLY CLUB

New year, new Y! To start off our 2017 campaign, we have kicked off a new option for staff giving. The Hourly Club consists of full- and part-time Y staff members who generously donate an equivalent of one hour's pay each pay period to the Annual Campaign.



The amount is conveniently spread over the year and is taken out of employees' bi-weekly paycheck. It is a great way to support the Annual Campaign no matter what their hourly rate is. Each staff member - from our CEO to part-time staff - can donate an equal percentage of their paycheck. Every gift, no matter how big or small, provides a meaningful impact in strengthening our community. As little as \$2 per pay period - or \$56 per year - provides a toddler with an 8-week developmental enrichment class.

LIGHTS ON AFTERSCHOOL



The Metuchen, Edison & South Amboy Branches celebrated Lights On Afterschool on Thursday, October 20th. Lights On Afterschool is a project of the Afterschool Alliance, a non-profit organization dedicated to ensuring that all children have access to quality, affordable afterschool programs. Lights On Afterschool was launched in 2000 and

the YMCA has been an active participant since its inception. Each year thousands of school age childcare programs host events to bring attention and raise awareness to this important cause.

The symbol of Lights On Afterschool is the light bulb, symbolizing that there is always a light on for youth! To celebrate the event this year, the children drew and strung afterschool lights which were displayed in the hallways and as a colorful backdrop for the children's presentations during Lights On Afterschool!

DID YOU KNOW...

In the early 1900's Charles Edgar left \$25,000 in a bequest which formed the original Y endowment fund. Today the endowment retains a balance of over \$1.762.000!

An endowment is a donation of money or property to a non-profit organization for their ongoing support. Usually the endowment is structured so that the principal amount is kept intact while the investment income is available for use, which allows for their donation to have an impact over a longer period than if it were spent all at once.
